DECREE
of the National Bank of Slovakia
dated 15 June 2010

amending and supplementing Decree of the National Bank of Slovakia No. 8/2008 on Fees for Actions of the National Bank of Slovakia, as amended

The National Bank of Slovakia, following an agreement with the Ministry of Finance of the Slovak Republic in accordance with Article 41 (3) of Act No. 747/2004 Coll. on Supervision of the Financial Market and on amendments and supplements to certain laws, stipulates as follows:

Article I

Decree of the National Bank of Slovakia of 6 May 2008 No. 8/2008 on Fees for Actions of the National Bank of Slovakia (Announcement No. 178/2008 Coll.) in the wording of Decree of 7 April 2009 No. 2/2009 (Announcement No. 147/2009 Coll.) and Decree of 15 December 2009 No. 11/2009 (Announcement No. 584/2009 Coll.) is amended and supplemented as follows:

1. In Article 2a, reference 2 above the word “registry” is replaced with reference 1a.

The footnote for reference 1a is to read as follows:

“^{1a}) Article 15 of Act No. 186/2009 Coll. on Financial Intermediation and Financial Counselling and on amendments and supplements to certain laws.”.

2. The footnote for reference 2 is to read as follows:

“²) Article 2 paragraph (2) letter (b) of Act No. 483/2001 Coll. on Banks and on amendments and supplements to certain laws, as amended.”.

3. In the Annex, part 1 is amended by item 6 to read as follows:
