## DECISION

Národná banka Slovenska, as the supervisory authority under Section 79(2) of Act No 39/2015 on insurance (and amending certain laws) as amended (hereinafter 'the Insurance Act'), acting through its Financial Market Supervision Unit – Supervision and Financial Consumer Protection Division (hereinafter 'Národná banka Slovenska') as the competent body for conducting proceedings and issuing decisions of the first instance pursuant to Section 1(2) and (3)(a), in conjunction with Section 5(1) and (2), Section 16(1) and (2) and Section 29(1), of Act No 747/2004 on financial market supervision (and amending certain laws) as amended (hereinafter 'the Financial Market Supervision Act'), hereby

### grants

**prior approval pursuant to Section 77(1)(b) of the Insurance Act to the following insurance undertakings:**

- **UNIQA poisťovňa, a.s.**, whose company registration number (IČO) is 00 653 501 and which has its registered office at Krasovského 15, 851 01 Bratislava, and is registered in the Commercial Register maintained by the Bratislava I District Court (Section: Sa; File number: 843/B) (hereinafter 'UNIQA' or a 'party to the proceedings');
- **UNIQA pojišťovna, a.s.**, whose company registration number (IČO) is 492 40 480 and which has its registered office at Evropská 136/810, 160 12 Praha 6, and is registered in the Commercial Register maintained by the Prague Metropolitan Court (Section: B; File number 2012) (hereinafter 'UNIQA – Czechia' or a 'party to the proceedings');
- **AXA pojišťovna a.s.**, whose company registration number (IČO) is 281 95 604 and which has its registered office at Evropská 810/136, Vokovice, 160 00 Praha 6, and is registered in the Commercial Register maintained by the Prague Metropolitan Court (Section: B; File number 12826) (hereinafter 'AXA' or a 'party to the proceedings') **and**

- **AXA životní pojišťovna a.s.**, whose company registration number (IČO) is 618 59 524, and which has its registered office at Evropská 810/136, Vokovice, 160 00 Praha 6, and is registered in the Commercial Register maintained by the Prague Metropolitan Court (Section: B; File number 2831) (hereinafter 'AXA life' or a 'party to the proceedings') **for the purpose of the merger of the parties to the proceedings, whereby UNIQA, AXA and AXA life are to be dissolved and UNIQA – Czechia is to become the successor company;** it does so on the basis of an application for prior approval lodged by the parties to the proceedings on 31 March 2021 and recorded under file number 100-000-281-100.

Národná banka Slovenska hereby determines, in accordance with Section 77(19) of the Insurance Act, that the time limit for carrying out the act for which this prior approval is granted is 12 months from the date on which it was granted.
